

Gas Safety Device (GSD) is the perfect device to make sure that gas safety with conventional gas system is sustained to the utmost level. As someone has said, "Prepare and prevent, don't repair and repent".

Regulator

One is on a safer mode, as the integral Excess Flow Check Valve System totally shuts off gas supply at the regulator level in case of medium to heavy leakage. Minor leakages are also monitored but without any shutdown.

It's simple to monitor minor leak. Observe if the needle slowly falls to its original position & its final down position. Verify from a certified mechanic. No fall down means zero leakage. Normally, keep the GSD & burner knob on an off mode.

The GSD has a LPG pressure indicator, which shows the amount of pressure in the LPG cylinder. When the cylinder has adequate amount of LPG, the indicator will be normally at the centre or anywhere in GAS region, depending on the outside temperature. When the LPG indicator comes to the bottom of 'Low Level' of the indicator, this indicates that the cylinder needs a replacement soon.
