Major Features and Benefits of Social & Ethical Audit!

Social & Ethical audit is a systematic study and evaluation of an organisation's social performance.

It is concerned with the possible influence on the social quality of life instead of the economic quality of life. Social & Ethical audit leads to a report on the Social & Ethical performance of a business unit.



#### **Features of Social & Ethical Audit:**

(i) The areas for Social & Ethical audit include any activity which has a significant social impact, such as activities affecting environmental quality, consumerism, opportunities for women and other disadvantaged people in society and similar others.

(ii) Normally, the Social & Ethical audit is that it can determine only what an organisation is doing in social areas, not the amount of social good that results from these activities. It is a process audit rather than audit for results.

(iii) Auditing Social & Ethical performance is very difficult because most of the results of Social & Ethical activities occur beyond the companies limit.

(iv) Both quantitative and qualitative data are essential for Social & Ethical audit to evaluate the organisations Social & Ethical performance.





#### **Benefits of Social & Ethical Audit:**

The benefits of the Social & Ethical audit are as follows:

(i) Social & Ethical audit enables the company to take close look at itself and understand how far the company has lived upto its Social & Ethical objectives.

(ii) It is the fact that Social & Ethical audit encourages greater concern for Social & Ethical performance throughout the organisation.

(iii) Social & Ethical audit provides data for comparing effectiveness of the different types of programmes.

(iv) Social & Ethical audit provides information for effective response to external claimants that make demands on the organisation. The society, welfare organisation and variety of others want to know what a business is doing in areas of their special interest, and a business needs to respond as effectively as possible. The Social & Ethical audit shows a business where it is vulnerable to public pressure and where its strengths lie.

### SA 8000

- SA 8000 is the first auditable global standard for ethical sourcing
- Designed for independent verification
- Ensures ethical sourcing of goods and services
- Based on: Universal declaration of Human Rights, UN Convention on the Rights of the Child, 11 Conventions of the International Labour Organization (ILO)
- Modelled after the established ISO 9001 and ISO 14001 standards

#### General

What is SA 8000 ?

SA 8000 is both a performance standard and a management system standard.

### The standard contains:

- Predetermined performance requirements (criteria)
- Requirements for a management system

#### and thus the assessment consists of two elements:

- Performance evaluation based on criteria
- Evaluation of the management system, which is a tool to achieve the performance targets defined by the criteria

Important: BSCI is not a management system. An extension of the requirements of the BSCI for a management system is provided by the SA 8000 standard which is comparable to the established DIN EN ISO 9001 standard
