> FIC 2018 Overview



This year marks the 22nd anniversary of Food Ingredients China. We are proud to say that FIC 2018 came to a successful conclusion on March 24, 2018 at NECCS with its scale being the No.1 of the industry: 1,408 exhibitors from 33 countries and regions including 458 overseas and 950 domestic ones; 49,715 visitors from 66 countries or regions including 3437 coming from overseas. Though the exhibition space has reached 116,000sqm. With these facts, FIC has again proved itself to be one of the largest and the most influential and professional brand show in the world in the field of food additives and ingredients.

> FIC 2018 Highlights



Professional

Exhibits covered the state-ratified 20 categories of food additives, 21 categories of food ingredients, 15 categories of food processing aide and others such as novel food and ingredients, natural and functional ingredients, food-related packing materials and machinery, test equipment and techniques, etc., covering all fields of the food industry.

Innovative

FIC 2018 opened up a new Hall—Natural and Functional Ingredients Hall for the collective exhibiting of natural products, natural extracts, functional ingredients and health care food.

International

FIC 2018 attracted 458 international exhibitors and 3437 international visitors. The Overseas Pavilion expanded compared to FIC 2017, and we had National Pavilions for the USA, Korea and Japan, and special pavilions for Taiwan.

Authoritative

3 forums/conferences concerning 45 topics were held alongside the show.
46 exhibitors chose to release their new products or techniques during FIC 2018.
And 12 senior experts from CFAA professional committee provided free on-site consultations to exhibitors and visitors from both home and abroad.

Effective

Of all the surveyed visitors, 94.3% expressed willingness to participate in FIC next year; of all the surveyed exhibitors, 21%were "quite satisfied" and 38% were "satisfied" with the show.




Comparison of FIC 2018 with previous sessions





Visitors Classification




Visitors' evaluation to FIC 2018









